

President's Report IX

Much of our achievements and accomplishment during the tenure 2019-21 have already been highlighted in my VIII report to 78 ICC meeting. For the last couple of months; we are all aware of the difficult phase that NRNA is going through in finalizing the delegates for the 10th IGA and we have emphasized on consensus and unity and all our energy has been drained by this issue. The letter forwarded by MOFA on 25/5/2078 disrupted our initial date of election on 20th October and NRN GC and IGA from 23rd to 25th October, 2021. This forced us to extend the tenure of the ICC as provisioned in NRNA Constitution 2003 (with amendment 2021) Clause No. 13.2 for six months; which was endorsed by the 80th ICC meeting. Though we had repeatedly discussed with MOFA; on 2078/8/3 MOFA forwarded another letter authorizing Patron Council to conduct the 10th IGA of NRNA. Unfortunately, many of us could not agree with these directives and as mandated by the 80th ICC meeting I took legal advice and was advised to seek legal remedy. The Patan High Court issued a Stay Order on the directives of MOFA but we have not been able to come to consensus and finalize the delegate issues even now.

Our MOU with ILO for the project "Covid-19 Response to Nepali Migrant Workers" will come to closure in February, 2022. Under this activity, from the grant of ILO, we have till date provided various support to 26,296 migrant workers. We have almost used 95% of the grant and the remaining 5 % has to be invested by NRNA and it is to be reimbursed by ILO once the project is complete. I propose that this meeting endorse to send an appreciation letter to ILO. Our donation of four 50 m³/hr medical oxygen plants in different provinces of Nepal have already reached the beneficiary hospitals and they are in the process of installing it. We still lack sufficient fund to complete the project and I request all committers to the fund to deposit their commitment. Our second Mobile Blood Transfusion Bus has already been delivered at Dhangadhi and we are planning to handover to the beneficiary on 17th January, 2022.

I am proud to note that the impacts of the pandemic did not deter us from implementing many of our activities envisioned in our Road Map for the tenure 2019-21 and I am equally anxious and eager to handover the tenure for 2021-23 to the newly elected ICC executives after resolving our differences amicably and I believe that TOGETHER, we can come out being more resilient, vibrant and untied.

Regular interactions between IES/OB members and other stakeholders on issues related to NRNA is a continuous process and some details have been highlighted for your reference.
