Report of NRNA ICC Women coordinator (July - Dec 2014)

- 1) Women right in Constitution of Nepal
 - equal gender right
 - issuing Nepali citizenship to children born to Nepali Mother or Father
 - Issuing travel document to children born in foreign land to Nepali mothers

Regarding these issues meeting were held with Rt. Honorable Mr. Sushil Koiral, Prime Minister of Nepal and Rt. Honorable Mr. Subhash Chandra Nembang, speaker of CA.

A letter was presented to Rt. Hon. Mr Subhash Chandra Nembang.

During the session of CNC in NRN day this issue was also raised in from of CA members and chairs of citizenship committee in CA.

2) Foreign migrant women worker

 Meeting was held with Labor and Employment Minister H.E. Mr. Tek Bahadur Gurung and DG of Department of Foreign Employment department .A Letter was presented to H.E. Minister.

NRNA had listed 5 major demands from Government of Nepal.

- To build a shelter (safe house) in countries exceeding 1000 Nepali women in foreign employment (NRNA can guide).
- The organizations giving false Health and orientation certificates should be taken under strict control.
- Banning Age and place is not a solution. After receiving the citizen every human has right to decide. So the age 30 years for Women going in FE should be removed and Government has to find other solutions.
- To secure Nepali citizens, Nepal Government has to sign agreement with all countries, where Nepali citizens go for FE.
- Micro financing should be provided to returnee women, legally gone in FE. This will help her establish life in Nepal and also go in FE legally.

b) MOU was signed in UN women and Paurakhi

UN women

A workshop was organized by UN women and NIDS after the NRN day. The result of this workshop is as below
